

TESTIMONY OUTLINE for Dr. Stephen Maltouse, NCI May 17 at 2 pm (Ottawa) – by zoom

1/ Your bio (1-2 minutes)

- practiced family medicine for 43 years in rural, urban, emergency room and palliative care settings.
- Involved in pediatric research overseas.
- Special interest in Integrative medicine (the combination of alternative medicine and conventional medicine)
- Founding President of both the Canadian Integrative Medicine Association and the Canada Health Alliance. CHA was formed during the Covid pandemic era (about 2 years ago) with 5000 members

Worked as family physician on Denman island for 13 years before taking a sabbatical in Jan 2020.

Provided an opportunity to closely examine both the pandemic and the response to it by government and the medical profession.

Time to keep an eye on global developments, e.g. the use of IV vitamin C for covid treatment –

- created a homeopathic prevention program, using world data on successfully treated Covid cases. Made available to frontline workers in our community. Follow-up protocol.

My recommendations to implement prevention methods, such as increasing vitamin D in nursing homes and amongst the general public, were ignored by public health officials and even led to an investigation by the BC College of Physicians and Surgeons.

He questioned her policies and called out the devastating harms caused by them. Since then, he has dedicated his time to raising awareness about the COVID injections and the right to informed consent without coercion. He spearheaded the Doctors on Tour initiative, bringing doctors and the public together in communities across BC in order to meet face-to-face and hear the information they were not getting on mainstream media.

2/ Your concerns as the covid crisis evolved and your advocacy for your patients.

Initial concern of death and suffering

Do hospitals stock IV vitamin C?

Importance of vitamin D supplementation and LTC – Letter to public health re vitamin D -- ignored

Non-pharmaceutical approach – **CIMA media statement and media release** – deficiencies in the general population **SLIDE 2**

As the evidence mounts:

1. Conflicting provincial mandates eg. Number able to congregate
2. Masking
3. Hand washing
4. Social distancing
5. Overdoses and suicides
6. Psychological effects
7. Children –

8. Few if any cases locally
9. Science by Media reporting of vaccine trials. Not safe or effective

In my community – insert in paper, meeting the community. Call from Dr. Derek Puddester after telephone complaints

Two outdoor meetings in community to discuss concerns

Letter by public health Dr Charmaine Enns – vaccine will be great – herd immunity. Safe and effective. **LETTER** SLIDE #3

- **REPLY** to My letter to the editor – response by 15 doctors – trust Bonnie Henry, public health and the CDC. Will get their shots when available. Best way to acquire herd immunity and get back to normal **LETTERS**

OCT 2020 -- Open Letter to Bonnie Henry British Columbia's chief public health officer, October 2020 – the lack of science in her policies, PCR, children **LETTER** – SLIDE # 4

- Tried to get colleagues to co-sign. None would sign for various reasons.
- to all Public Health Officers in BC, including First Nations Health director Dr. Behn-Smith, who allegedly practices functional medicine (and should know better)

A group on Vancouver Island mailed my Open Letter to about ½ of the physicians in BC with my cover letter asking if they had noticed anything wrong with the Public Health Policies – contact me.

Some good responses, some bad. One doctor informed me that I had a troubled youth and was now seeking attention. **LETTER Dr. Michael Vance --- read excerpt**

3/ The consequences you faced for that advocacy.

Immediate response after my Open Letter from College requesting an interview. Not based on patient complaints.

Hiring of CMPA lawyers, not aggressive, ask CMPA for my lawyer of choice (Mr. Rocco Galati) – refused. Fired CMPA lawyers in Vancouver.

Met with college, accompanied by Mr. Galati in late 2020 -- the college refused to record, saying doctors don't like it! Meeting cancelled after about 10 minutes. Other physicians reporting false material in the college's "recollection of what was said".

Continual complaints from

- non-patients, college
 - even asked for responses to complaints from people who read a CBC article.
 - Asked to reply to a complaint from a father who wanted his daughter vaccinated against his wife's wishes. I wrote an affidavit for the court case reviewing the scientific literature, including the trials for that age group, and, while the case was still before the courts, the college demanded a response, despite intimidation or harassment of witness.
- Hit pieces in the media

- Loss of my medical license (suspended) in March 28, 2022 for writing vaccine and mask exemptions and allegedly circumventing public health policies
 1. Only way to get a medical exemption is to have a near death experience with 2 vaccines from different manufacturers. Even myocarditis only gives you 90 days.
 2. If allergy, even anaphylaxis history, must sent to allergist for rapid assessment. Often send back saying OK, just divide vaxx into 5 portions and stand by with adrenalin.
- De-banked by the RBC in May 2022 given 2 months to remove all accounts and mortgages would not be renewed. SLIDE #8

4/ The history of the Doctors Tours that you and Charles Hoffe did in Western Canada and what you were trying to achieve with those tours.

- Dr. Henry pushing safe and effective vaxx on children SLIDE #9
- Children not at risk SLIDE #10
- VAERS deaths SLIDE #11
- Plenty of young adult deaths SLIDE #12
- TOUR MAP #13

Two sets of 3 tours

1. Doctors on Tour: Educate before you vaccinate --- going after our children

2. Doctors on Tour: Justice for the vaccinated --- number of vaxx injured in the audience increasing

SLIDES #20 -

- Gaslighting by media, shunned, ridiculed, mistreated by doctors, ignored or worse by families, told to get more shots!
- No place to turn for support or information

Final – the Grey Cup in Regina – SLIDE #36- 48

5/ Explain what can be offered to those who may be in harm's way following receipt of the covid injections.

- What's in the shot SLIDE #50
- 3 categories: had the shot with symptoms, had the shot without symptoms, shedding
- All should be treated.
- A general approach: inexpensive, accessible, self-applied at the beginning, not too complicated, in order of potential benefit SLIDE # 51
