UPON THE APPLICATION of the Applicants, Dr. A, Dr. B, Dr. C, Dr. D, Dr. E, and Dr. F (together, the "**Applicants**", and the "**Restricted Court Access Application**"); **AND UPON HAVING READ** the Affidavits of the Applicant, Dr. A sworn January 6, 2022 and January 20, 2022; **AND UPON HEARING** the submissions of counsel for the Applicants, counsel for the Respondent, Annette Lewis, and counsel for the Respondents, Alberta Health Services and the ABC Hospital (the "**Respondent Hospital**"); **IT IS HEREBY ORDERED AND DECLARED:**

1. That, pursuant to Rules 6.28-6.36 of the *Alberta Rules of Court*:
 - (a) The Applicants and the Respondent Hospital, individually, together and collectively, shall be identified exclusively by pseudonyms in all filed materials, written or oral submissions and decisions of the court in this matter;
 - (b) All previously filed materials, and this Restricted Court Access Order, shall be sealed on the Court file and shall not form part of the public record, notwithstanding Division 4, Part 6 of the Alberta Rules of Court, and that such materials will subsequently be re-filed with no changes other than those required to comply with this Restricted Court Access Order;
 - (c) A publication ban in relation to this matter is in effect with respect to the names of the Applicants and any identifying information related thereto including, without limitation, any references to:
 - (i) The name of the hospital in which the Applicants provide medical care;
 - (ii) The name of the city in which the Applicants provide medical care; and
 - (iii) The specific organ at issue in this matter;
 - (d) The foregoing publication ban includes but is not limited to the publication, posting, sharing, distribution, dissemination, broadcasting or communication of materials through any platform, including but not limited to:
 - (i) Online media;
 - (ii) Social media; and
 - (iii) Print media;
 - (e) All materials published or made publically available by the parties and/or their counsel prior to this Restricted Court Access Order shall be withdrawn or redacted such that they comply with this Restricted Court Access Order;

- (f) The media shall be notified of this Restricted Court Access Order and will be provided with a copy of Schedule "A" attached hereto which will be of the same form and substance as this Restricted Court Access Order except for with respect to the identification of the Applicants and Respondent Hospital by name in the style of cause, recitals and paragraph 1(a);
- (g) The media shall have an opportunity to set aside this Restricted Court Access Order upon five days notice to the Applicants and the Respondents; and
- (h) None of the materials related to this Restricted Court Access Application shall be published without the Court's permission.
