Morning Dianne,

I hope this finds you well. We received additional information we were requesting related to your case late last week , I forwarded everything I was able to access to the Associate Medical Officer of Health (AMOH) team. At this point they will review all the information provided- it may take some time, and in your file there was approximately 6 months' worth of data.

Regarding your health situation, I empathize with your waiting for an update on this investigation. As soon as I have the case returned to me; I will follow up with you directly . Granted, I know we spoke at length about the scope of this Toronto Public Health investigation, and I did implore you in the meantime (or after the conclusion of the investigation), to continue to seek healthcare with the providers of your choosing. That said, I have no control over the health recommendations another healthcare professional gives you, or who's healthcare advice you feel comfortable following regarding vaccination, or your health in general. Any questions or concerns regarding healthcare advice, risk/benefits/possible consequences of any actions related to healthcare advice; need to be discussed directly with the individual who gave the advice.
