

Excess deaths in Alberta surge past 10,000 - evidence of government cover-up (Part 1)

Excess mortality is surging in every highly COVID-19 vaccinated country and it's a hot topic right now. CBC just reported that Alberta's excess deaths have surged past 10,000 during 2020-2022 ([click here](#)). Last summer, CTV reported the #1 cause of death in Alberta was "unknown causes" which took the lives of 3362 Albertans ([click here](#)), a number that is set hit 4000+ this year, according to Statistics Canada ([click here](#)).

In this multi-part series, I will explore what the Alberta government knew about COVID-19 vaccine injuries & deaths, and how it repeatedly censored & hid crucial data and information from the public. No wonder Alberta's former Public Health Chief Dr. Deena Hinshaw is now hiding in BC, under NDP's protection.

The numbers of excess deaths and COVID-19 vaccine deaths are very difficult to pin down. Here are some current estimates that are coming in:

- USA - **270,000** in 2022 (source: [Ethical Skeptic](#), [BMC Skidmore](#), USMortality.com)
- Germany - **103,000** in 2022 (source: German govt, OECD, EuroMOMO [click here](#))
- UK - **54,000** in 2022 (source: BBC [click here](#))
- Japan - **91,000** in 2022 (source: [click here](#))
- Australia - **42,000** in 2022 (source: [click here](#))
- Alberta - **4000** in 2022 (source: [click here](#))

A good quick rule of thumb is: highly COVID vaccinated countries lost **0.1%** of their total population to "excess deaths" in 2022. That's **1 in every 1000 people**, dead.

Some countries lost a bit more than 1:1000, like Australia (42K/26M) and Germany (103K/83M), and some a bit less than 1:1000, like USA (270K/332M), Japan (91K/126M), Netherlands (14K/18M) and Alberta (4K/4.6M).

If 4000 Albertans died from COVID-19 Vaccine injuries, pardon me, “excess deaths” in 2022, what did the Alberta government know and when did they know it?

Alberta government published “vaccine outcomes”...for a little while

Starting in June 3, 2021, Alberta govt started releasing data on “vaccine outcomes” on its website ([click here](#)). One of the graphs had cases/hospitalizations/deaths vs time from 1st vaccine dose to COVID diagnosis. It looked something like this:




Figure 11: Time from first dose (left) and second dose immunization (right) to COVID-19 diagnosis by age group:

TOP: cases

MIDDLE: of those who became hospitalized


BOTTOM: of those who died from COVID-19

Note: First dose immunization also includes people who became a case prior to their second dose immunization date.

COVID-19 hospitalizations reported are not due to immunization events.


Right away you can see the “VAERS pattern of COVID-19 Vaccine deaths” - following 1st vaccine dose, there is a pattern of increased COVID infections, hospitalizations and deaths within the first 30 days but mostly in the first 14 days - the Alberta govt counted these as “unvaccinated”. Even back then, they were covering up COVID Vaccine injuries and deaths post 1st dose.

But it gets really interesting after the 2nd vaccine dose. What transpired over the next 8 months is truly shocking. Let’s look at the COVID-19 cases in the double vaccinated from July until December 2021:



If COVID-19 vaccines worked, the top left graph would have stayed relatively unchanged. After all, 2 doses were supposed to protect you from COVID-19 infection. Only they didn’t. Instead, we see two big spikes of infection in the double vaccinated as time goes by, at about 90 days and 180 days after 2nd dose. And these only get worse with time across all age groups but mainly in the 12-59 year olds.


The final graph that the Alberta government released on January 13, 2022 is absolutely astonishing ([click here](#)):



What are we even looking at? Who is getting COVID-19 infected the most in this wave? The double vaccinated (ages 12-59) at 5-7 months (150-210 days) after their 2nd vaccine dose are getting absolutely hammered by COVID-19. But why?

Their immune systems are destroyed. They are defenseless against infections. “Sorry, you now have AIDS” is what the Alberta government might as well have said to the double vaccinated at this point. It would have been much closer to the truth.

But surely COVID-19 vaccines protected against hospitalization and death?



NO. The pattern is the same, only it's mainly the older populations (60-74 and 75+) who are being hospitalized and are dying at 5-7 months after their 2nd dose, now that their immune systems are destroyed.

This was evidence of “**negative vaccine efficacy**” - meaning that the mRNA vaccines were making people more susceptible to infections, hospitalization and death, than those who were never vaccinated to begin with.

For those who were paying attention, “negative vaccine efficacy” of Pfizer and Moderna COVID-19 mRNA Vaccines was first reported in Denmark ([by Dr.Christian Holm Hansen](#)), as well as in the UK in December 2021.





The UK HSA/PHE COVID-19 Vaccine Surveillance reports were showing that the vaccinated ages 18-69 were getting sicker at far higher rates than the unvaccinated.

UK CoV2 INFECTIONS Per 100,000 by Vaccination Status (Dec 22, 2021)



When your immune system is severely damaged, you are susceptible not just to all kinds of infections, but also to other injuries and diseases (i.e. cancer), as well as sudden and unexpected deaths.

Faced with the reality of negative mRNA vaccine efficacy, the Alberta government did the only thing it knew how to do well - censorship. On January 14, 2022, the Alberta government deleted this data from its website (Figure 12: Cases / hospitalizations / deaths vs time from 1st and 2nd vaccine dose) and never posted it again.

Just in time too, as kids 5-11 years old were now starting to get sick within 30 days of their first mRNA jab and that was data that the government REALLY didn't want Albertans to see:



Also, by January 14, 2022, 81% of all new COVID-19 cases were vaccinated.

Note:

Vaccine status category is based on protection. Doses administered within 14 days prior to a person's COVID-19 diagnosis are not considered protective; as a result, partial or complete vaccination categories only include those identified as cases over 14 days past their first or second immunization date.

But the Alberta government was too busy rolling out the 3rd COVID-19 vaccine dose - the booster shot. There was simply too much money to be made by the mRNA pushers, to worry about the double vaccinated and their destroyed immune systems.

In Part 2, I will examine in depth how quickly the 3rd COVID-19 vaccine dose (1st booster shot) failed in Alberta, what the Alberta government did to cover that up, and how the triple vaccinated quickly became the sickest group of all Albertans.
